#### PLACE OF INTERVIEW:

ICAR-Central Institute for Subtropical Horticulture "CISH Guest House" at Raebareli Road, P.O. Dilkusha (Lucknow Cantonment Area) near Telibagh, Lucknow - 226002 (U.P). (approx. 07 Kms. from Charbagh Railway Station, Lucknow).

Note: Reporting Time is 9.00 A.M. on the date of interview i.e. one hour before of the time. Candidate coming late after half an hour of the reporting time will not be allowed for interview. Since the documentation process is also to be conducted before walk in interview, therefore the candidates are required to bring all the original documents along with a set of photocopies for documentation process, as per scheduled time on the date of interview.



#### Terms & conditions for the contractual post of JRF:

- 1. The candidates are requested to bring the necessary essential qualification certificates and a Photostat copy along with the prescribed form (given at Annexure-I).
- 2. Engagement period: The post is purely temporary on a contractual basis for duration mentioned above from the date of joining under the project. The engagement to the above post shall stand automatically terminated with the project. However, the engagement can be extended in case the project duration is extended by the funding agency subject to satisfactory performance of the candidate.
- 3. The selected candidate (s) shall not claim regular appointment at this Institute, as the post is temporary and co-terminus with the project.
- 4. The candidates should bring the filled-in application form (as per the format annexed), all the original certificates from matriculation onwards, date of birth certificate, degree certificate either original or provisional and one set of the self-attested photocopies of all the required certificates from matriculation onwards and an attested copy of recent passport size photograph pasted onto the application form. #### Terms & Conditions for the contractual post of YPs:

- The candidates are requested to duly filled application form, in the enclosed proforma, along
  with self-attested copies of certificates in support of age, caste, educational qualifications,
  experience and other credentials at the time of Interview. Candidate should bring Original
  certificates for verification. Incomplete applications/ Non submission of certificates will not be
  entertained. The shortlisted candidates will be selected through the process of walk-in interview.
- Initial engagement of Young Professionals will be for one year or the specified duration as mentioned above, which may be extended for a maximum of two years period, or the project duration, whichever is earlier, subject to requirement of the services of the YP in the organization and subject to satisfactory performance of the candidate.
- The Institute reserves the right to increase/decrease the number of vacancies as per requirement.
- Consolidated emoluments of Young Professional-I & II (YP-I & YP-II) for the duration of engagement is fixed. No other Allowances will be payable.
- TA/DA will be admissible to YPs for undertaking domestic tour for official work as per rules.
