	of opening of the tender/ auction by the successful bidder/tenderer, before commencement of harvest. No part payments of the bid will be accepted. If the successful bidder fails to comply with the payments, within the stipulated time would stand to forfeit the EMD.
13.	The successful bidder should not sub-lease the tender and in the event of this office coming to know about the sub-leasing of the tender, the entire amount shall stand forfeited as per rules.
14.	The tenderer <u>shall harvest crop only on working days</u> and facilitates the day-to-day harvesting records to the Scientist/ Technician of the Institute upon request. Tenderer will take out the harvested produce only after obtaining gate pass.
15.	The tenderer shall have no objections for the officials of this Institute to carry out the research activities/ farm operations of routine nature by this Institute including plant propagation activities. A note below Annexure-A Indicates the sample quantity of fruits/Varieties to be spared for research use without any charges to the Institute.
16.	Except the EMD of the successful bidder and the next highest bidder, the EMD of all the unsuccessful bidders' received through crossed Demand Draft will be returned immediately to the concerned on the spot after the process of bid/ auction is completed.
17.	WATCH & WARD : Watch and ward arrangements are required to be made by the successful bidder/ tenderer themselves immediately after the award of bid and due permission of the Institute for stay in the Institute premises be obtained from the Incharge, RRS, Malda and the Institute will not be responsible for the theft and damages by natural calamities or by birds and animals, insect pests and diseases .
18.	The farm produces will be harvested from the trees/plots by the bidder/ tenderer under the supervision of Incharge by the bidders own labourers during the working days. No child labour shall be employed for any of the works involved.
19.	The Block(s)/areas including in the tender may or may not be irrigated during the whole period of tender.
20.	The bidders/ tenderer violating any of the above terms and conditions would stand to forfeit the EMD/ Performance security 10% of the bid amount and the Director, ICAR-CISH, Lucknow, reserves the right to execute this clause. No complaints would be entertained in this regard.
21.	LAST DATE for completion of harvesting will be 31-07-2019.
22.	The Institute functions under the provision of RTI Act, 2005 : All information provided by the bidders under the act is liable to be disclosed.
23.	The tenderer/Bidder can download the Tender from the website of the Institute website : <u>www.cish.res.in</u> but in this case the tenderer should enclose the Bank Draft of the value of Tender Form Rs. 500.00 along with the duly filled Tender Form.
24.	RIGHT OF ACCEPTANCE : The Institute in its absolute right, may accept the highest bid or any tender and reserves itself the right of accepting the whole or any part of the tender or portion of the rate quoted.
25.	ARBITRATION : In the event of any dispute in this regard, the right of adjudication

	shall rest with the Director, ICAR-Central Institute for Subtropical Horticulture, Lucknow and the final decision will be binding on all parties.	
26.	. AGREEMENT & SECURUTY DEPOSIT : The successful bidder/ tenderer should execute an agreement on a non-judicial stamp paper worth Rs. 100.00 and also deposit 10% of the bid price, as a Performance Security within 7 days from the date of opening of tender/ auction(refundable after the completion of harvesting)	
27.	During the period of harvesting of the mango crop if any loss of the institute's property by the contractor/his Laborers' the same will be recovered from the contractor.	
28.	The bid of highest acceptable responsive bidder should normally be accepted and an acceptance/sale order be issued. However, if the price offered by that bidder is not acceptable, a negotiation may be held only with that bidder.
