Terms and conditions of Tender –cum – Auction

1.	The tenderer may inspect the standing crop to be auctioned on any working day starting from 19-05-2017 to 26-05-2017 between 10:00 AM to 1:00 PM with the permission of the Farm In-charge/nominated technical officer by the concerned In-charge.
2.	The tender should be submitted in the prescribed tender form obtainable from the Office of ICAR-Central Institute for Subtropical Horticulture, RRS, Malda on any working day up to 4:00 P.M. on 27.5.2017 during office hours at the cost of ₹ 500.00 only or download from the Institute's website www.cish.res.in up to 27-05-2017 at 4:00 P.M.
3.	 (i) The Earnest money Rs.100000/- (Rupees One lakh only) for the mango crop of ICAR-CISH, RRS, Malda should be deposited in the form of Crossed Demand Draft in favour of "ICAR Unit - CISH, Lucknow" by the bidder/tenderer along with the tender form. The bid/ tender will not be considered if the earnest money is NOT DEPOSITED ALONG WITH THE TENDER. No request for transfer of any previous deposit of earnest money will be entertained. The No. and date of demand draft should be indicated in tender form. (ii) The tenderer/bidder should mark his signature on the tender form, without
	which the bid is liable to be rejected.
4.	No cash transaction for payment of EMD will be entertained.
5.	The tenderer should furnish his full name and address on the tender form with telephone/mobile Number along with Identity proof.
6.	The tenderer should specify about the name of auction on the sealed envelope and he should fill in the particular portion in the form.
7.	The location wise prices quoted in the tender must be for lump sum harvest in respect of the crop proposed to be auctioned and should be mentioned clearly in the enclosed form, which is required to be put in the tender box placed in the Officer In-charge ICAR-CISH, RRS, Food Park, English Bazar, Malda along with the earnest money in a sealed cover.
8.	The tender should be submitted in a sealed cover marked "Tender for Purchase of Mango crops for 2017 at ICAR-CISH, RRS, Malda, W.B. The tender will also be accepted by Courier / Registered Post on or before due date i.e. 29-05-2017 up to 11:00 A.M.
9.	Last date and time for receipt of tender is 29.05.2017 at 11:00 A.M. at the office located at ICAR-CISH, RRS, Food Park, English Bazar, Malda
10.	Time and date of opening of tender/auction as mentioned in the tender document will be on 29.05.2017 at 11:30 AM at ICAR-CISH, RRS, Food Park, English Bazar, Malda
11.	OPENING OF TENDER: Bidders/tenderers are at liberty to be present or authorize in writing a representative to be present at the time of bid/opening of tender and if required open auction will be held only among the bidders.

t	MODE OF PAYMENT: 1/3 rd of the bid amount has to be deposited on the spot and rest of the Bid amount is to be paid by bank draft within 5 (Five) days from the date of opening of the tender/ auction by the successful bidder/tenderer, before commencement of harvest. No part payments of the bid will be
	accepted. If the successful bidder fails to comply with the payments, within the stipulated time would stand to forfeit the EMD.
	The successful bidder should not sub-lease the tender and in the event of this office coming to know about the sub-leasing of the tender, the entire amount shall stand forfeited as per rules.
r	The tenderer <u>shall harvest crop only on working days</u> and facilitates the day-to-day harvesting records to the Scientist/ Technician of the Institute upon request. Tenderer will take out the harvested produce only after obtaining gate pass.
i i s	The tenderer shall have no objections for the officials of this Institute to carry out the research activities/ farm operations of routine nature by this Institute including plant propagation activities. A note below Annexure-A Indicates the sample quantity of fruits/Varieties to be spared for research use without any charges to the Institute.
r	Except the EMD of the successful bidder and the next highest bidder, the EMD of all the unsuccessful bidders' received through crossed Demand Draft will be returned immediately to the concerned on the spot after the process of bid/auction is completed.
t c f	WATCH & WARD: Watch and ward arrangements are required to be made by the successful bidder/ tenderer themselves immediately after the award of bid and due permission of the Institute for stay in the Institute premises be obtained from the In-charge RRS, Malda and the Institute will not be responsible for the theft and damages by natural calamities or by birds and animals, insect pests and diseases.
t c	The farm produce will be harvested from the trees/plots by the bidder/tenderer under the supervision of In-charge by the bidders own labourers during the working days. No child labour shall be employed for any of the works involved.
	The Block(s)/ areas including in the tender may or may not be irrigated during the whole period of tender.
S	The bidders/ tenderer violating any of the above terms and conditions would stand to forfeit the EMD/ Performance security 10% of the bid amount and the Director, ICAR-CISH, Lucknow, reserves the right to execute this clause. No complaints would be entertained in this regard.
21. L	LAST DATE for completion of harvesting will be 31-07-2017.
	The Institute functions under the provision of RTI Act, 2005: All information provided by the bidders under the act is liable to be disclosed.

23.	The tenderer/Bidder can download the Tender from the website of the Institute website: www.cish.res.in and website: https://eprocure.gov.in/eprocure/ but in this case the tenderer should enclose the Bank Draft of the value of Tender Form ₹ 500.00 along with the duly filled Tender Form.
24.	RIGHT OF ACCEPTANCE: The Institute in its absolute right, may accept the highest bid or any tender and reserves itself the right of accepting the whole or any part of the tender or portion of the rate quoted.
25.	ARBITRATION: In the event of any dispute in this regard, the right of adjudication shall rest with the Director, ICAR-Central Institute for Subtropical Horticulture, Lucknow and the final decision will be binding on all parties.
26.	AGREEMENT & SECURUTY DEPOSIT: The successful bidder/ tenderer should execute an agreement on a non-judicial stamp paper worth ₹ 100.00 and also deposit 10% of the bid price, as a Performance Security within 7 days from the date of opening of tender/ auction(refundable after the completion of harvesting)
27.	According to Annexure –'A' Mangoes will be taken from Contractor free of cost for Research Purpose.
28.	During the period of harvesting of the mango crop if any loss of the institute's property by the contractor/his Labourers' the same will be recovered from the contractor.
