Corrigendum to Tender Notice for Canteen Services

The Tender Notice for Canteen Services at ICAR-CISH, Lucknow was published/uploaded on institute's website as well as on Government e-publishing system on 21st August, 2019.

The Pre-Bid Conference of the above said tender was held on 30th August, 2019 in which three indenting vendors participated and based on the feedback, suggestions and discussions held in the Pre-Bid Conference, ICAR-CISH, Lucknow is hereby amending few clauses and conditions of the tender document as noted below for general information to the vendors and service providers.

Instructions to bidders (ITB):-

12 (b)- Financial Bid – The license fee has now been revised to Rs. 1,000/- (One thousand Rupees) per month instead of Rs. 2,000/- (Two thousand Rupees) per month. The bidders quoting license fee less than Rs. 1,000/- per month will not be applicable.

17- The successful bidder shall have to deposit Performance Security of Rs. 15,000/- (Fifteen thousand Rupees) instead of Rs. 18,000/- (Eighteen thousand Rupees) as noted earlier.

General conditions of contract (GCC):-

1- Performance Security is now revised to Rs. 15,000/- (Fifteen thousand Rupees) instead of Rs. 18,000/- (Eighteen thousand Rupees).

4- No license fee will be increased in case contract is renewed for second and third year i.e. license fee shall remain constant/fixed for entire period of contract including extended period.

9(a)- Fixed amount of electricity charges at the rate of Rs. 500/- (Five hundred Rupees) per month instead of actual consumption on commercial rates for kitchen of the canteen will have to pay along with the license fee.

9(b)- Water charges will not to pay but misuse of water is prohibited.

Essential technical criteria check list (Annexure-I):-

2- Continuous experience in canteen services is now reduced to 2 years in place of 3 years.

3- Annual turnover for last 3 years is revised to Rs. 3 lakhs in place of Rs. 5 lakhs annually. The certificate of turnover can also be submitted from other agencies/authorities other than the Chartered Accountant.

4- Service report of 2 years is required in place of 3 years.
