



The interested firms are required to deposit Earnest Money Deposit (EMD) of Rs.137500/- (Rupees One lakh thirty seven thousand five hundred only) in the form of DD/FDR/BG in the favor of ICAR Unit-CISH, Lucknow before opening the technical bid. Terms and Conditions:-

1. According to F.O.R condition, the place of delivery of the goods/services will be **ICAR-Central Institute for Subtropical Horticulture, Rehmankhera, Kakori, Lucknow-226101.** The firm will bear the charges of delivery to the above given address. The firm will be responsible for any kind of loss during transportation of the goods/services to the Institute. If, firm wish to supply the goods/services personally to the institute, it will be accepted accordingly.

2. According to the supply order, Institute has the rights to cancel partially or completely supply order before the delivery of the goods/services. The partial supply of the goods/services given in the order will not be accepted until there is a consent order in this respect. All the conditions according to tender/quotation as well as GeM terms & conditions will be applicable also.

3. Firm will be responsible for the payment of all types of taxes. Payment of Firm's Supply Bill will be made through R.T.G.S./N.E.F.T. Bank details must be sent with the Bill.

4. The rates given in the tender will not be changed. Supply order will be issued in INR only.

5. After the date of delivery, every week 0.5 % liquidated damage charge will be charged according to the rules. This liquidated damage charge will be maximum 10% of the purchase cost of the goods/services.

6. Detailed specifications of the goods/services to be supplied. Only one Make/Model be quoted and alternative Make/Model will not be considered. Scanned copy of make and model of quoted product/item by the firm shall be mentioned in the technical bid supported by brochures. IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

7. More than one tender/quotation cannot be submitted by one firm for one goods/services participation of Sub-dealer/agent is not acceptable. In the tender, either the manufacturer or its authorized dealer can be considered as valid bidders. However, in cases where the manufacturer has submitted the bid, the bid of its authorized dealer will not be considered and EMD will be returned/forfeited. And in case of violations, both infringing bids will be rejected. Scanned copy of OEM certificate may be attached. In case of dealer, authorization certificate issued by principal manufacturer firm may be attached.

8. The tenders/quotations which will be received within stipulated time only will be accepted. After stipulated time, no tenders/quotations will be accepted. For this, Institute will not be responsible.

9. Dispute Resolution Mechanism: If any dispute or difference of any kind arises between the purchaser and the supplier in connection with the contract, the parties shall make every effort to resolve the same amicably by mutual discussions, However, if the parties fails to resolve the disputes or differences by such mutual discussion within 30 days, either the purchaser or the supplier may give notice to the other party of its intention to refer the same to arbitration. The arbitration will be conducted by a sole arbitrator, who will be appointed by the Director, ICAR-CISH, Rehmankhera, Kakori, Lucknow, and the procedure to be followed in this respect will be as per the Indian Arbitration act, 1996. The venue of the arbitration shall be the place i.e. ICAR-CISH, Rehmankhera, Kakori, Lucknow from where the contract is issued. No TA/DA, etc. will be paid by this Institute to the Firm. In case any legal dispute the jurisdiction will be Lucknow (U.P.) India.

10. The price bid is to be filled in the prescribed price bid form. The price validity 90 days and delivery 30 days from the issue purchase order.

11. After comparative statement of all received tenders/quotations by the purchaser, those which will be found technically responsive and whose price will be reasonable and suitable can be given supply order of the goods/services. The rate may be quoted of each items separately, however purchase will be considered/made overall lowest rate quotee firm.

12. Warranty two years from the date of installation. The supplying firm will submit performance security 03% (Three percent) of the purchase cost as in the form of DD/FDR/BG in the favor of ICAR Unit-CISH, Lucknow. The institute will not give any interest on this. The validity of the performance security must be 60 days more after the completion of the warranty period. Before executing supply, the successful bidder will have to deposit performance security as per rule which is equal to 3% (Three percent) of the ordered value of goods.

13. Payment will be released after satisfactory installation and commissioning of goods. The Firm will also be provided training to our staff free of cost.

14. In case, the successful bidder shows inability at any stage, after the contract is finalized and awarded, for whatsoever reason (s), to honour the contract, the earnest money/performance security deposited would be forfeited.

15. Force Majeure Clause:- The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods. Epidemics, quarantine restrictions, strikes, lockout or any act of war. Notice of the happening of any such event is given by either party to the other within 15 days from the date of occurring thereof. However either party at its discretion can terminate the contract in such cases. If any changes in rule of Force Majeure Clause from time to time will also be applicable.

16. Termination of Contract: - Time shall be the essence of the contract. The purchaser shall have the right to terminate the contract without any notice in part or in full in any of the following cases:

(A) The delivery of the material is delayed for causes not attributed to Force Majeure after the scheduled date of delivery.

(B) The seller is declared bankrupt or becomes insolvent.

(C) The delivery material is delayed due to causes of Force Majeure by more than 30 days.

(D) In case Performance Security is not furnished within the time period specified by the purchaser.

(E) Supply in the case of successful tenderer should strictly confirm to the specifications of the goods/services being purchased.

(F) Any change in Address/Telephone/Fax/e-mail of the tenderer should immediately be informed. The state of non-communication by the firm will make the offer liable for rejection.

(G) This institute is registered for purchasing of goods/services for the research work under the Ministry of Science and Technology, Department of Scientific and Industrial research, Technology Bhavan, New Mehrauli Road, New Delhi, for purpose of availing customs duty exemption in terms of Government notification No. 51/96 customs dated 23.07.1996 as amended from time to time for research purposes only. 17. In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.

Pre-qualification Criteria

1. Experience and past performance:

The bidder (manufacturer or principal of authorized representative) should have regularly for at least last three years ending 31st March, 2023 manufactured and supplied (erected/commissioned) equipment with the same or higher specification and the bidder should have manufactured and supplied at least one number of equipment in at least one of the last three financial years.

2. Capability:

Equipment and manufacturing facilities-the bidder must have an annual capacity to manufacture and supply (erect/commission) at least 2-3 number products i.e. equipment of similar or higher configuration/specification as specified in the tender document.

3. Financial Standing:

The average annual financial turnover of the bidder during the last three years ending 31st March, 2023 should be Rs.100.00 Lakhs (Rupees one hundred lakhs only) as per the annual report (audited balance sheet and profit and loss account) of the relevant period duly authenticated by a Chartered Accountant of the company/firm.

4. Authorized representative:

Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified provided their principal manufacturer meets all the criteria above without exemption and the principal manufacturer furnishes legally enforceable tender specific authorization in the prescribed form assuring full guaranty and warranty obligation as per the conditions of contract.
